Protecting the Unborn: 100% Pro-life

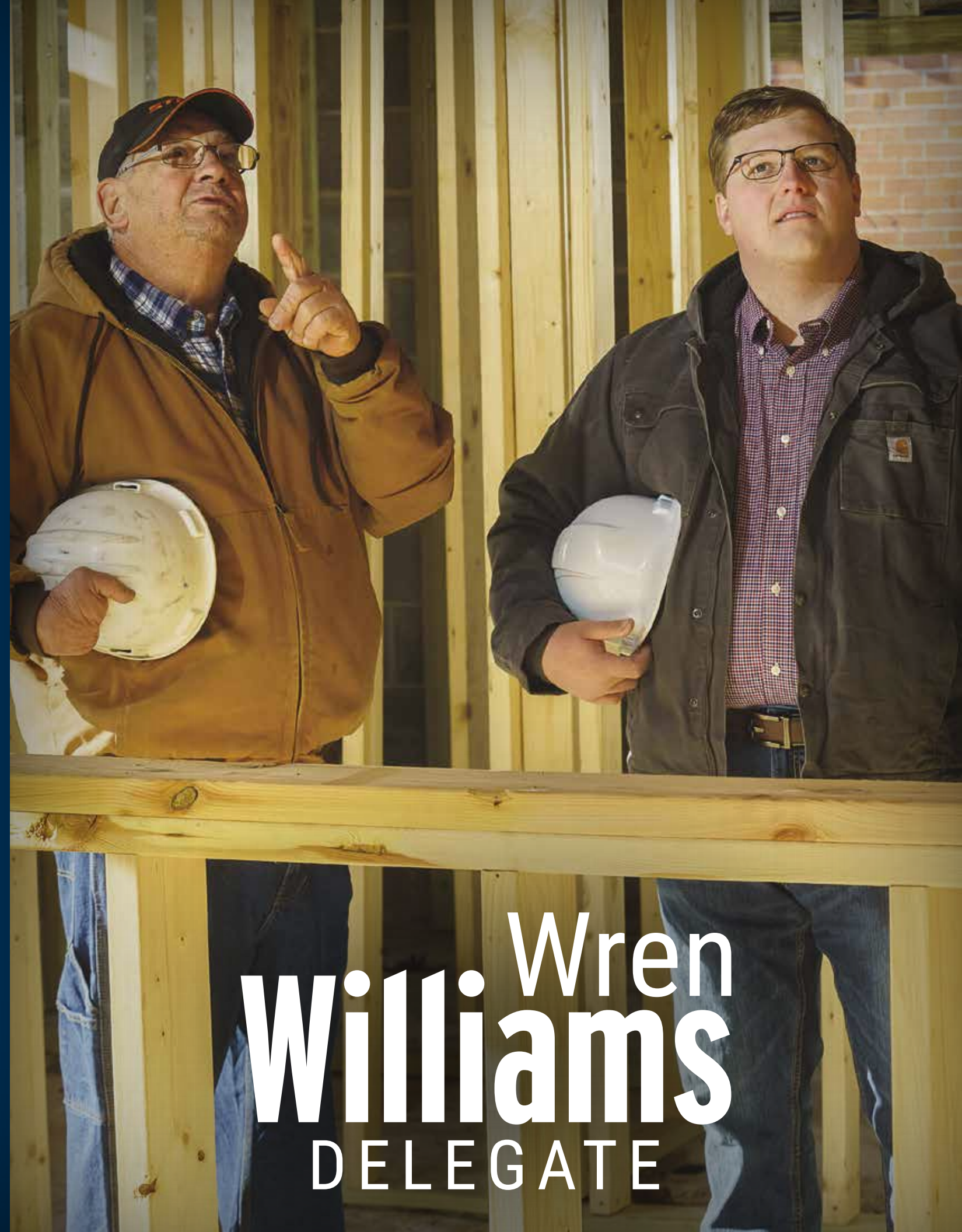
